Artist Checklist for the 2022 Roycroft Campus Art Shows:

Please look over and check each item that you are applying for and complete:

- Complete and sign application form
- Send non-refundable jury fee check of \$25. There is only one jury fee for the year, no matter how many of the three shows you are applying for. The jury fee is waived for artists from the Arts & Craftsmen Guild, the Guild of St. George or the Roycrofters-at-Large-Association. Please check the Guild box you are a juried artist in, if applicable.

 - Guild of St. George
 - Roycrofters-at-Large-Assoc.

Include an individual check of \$175 for a 10x10 booth space, or \$350 for a double space for each show you are applying for. Checks will be cashed upon their arrival. Please make sure you have proper funds in your account. If you are not accepted into a specific show, this booth fee will be reimbursed.

A late cancellation, not showing up the day of the Show, or leaving early from a Show, does not guarantee any form of refund.

- Art & Antiques Show: include your check of \$175 for single space, or \$350 for a double space.
- Fall Festival: include your check of \$175 for single space, or \$350 for a double space.
- Holiday Show: include your check of \$175 for single space, or \$350 for a double space. (Space is limited for this show, please call to request a double space.)
